

NOTICE OF LAC SEUL FIRST NATION LAND CODE RATIFICATION VOTE

TAKE NOTICE that a Ratification Vote will be held in accordance with the Lac Seul First Nation Community Ratification Process **on September 15, 2023** in order to determine if Eligible Voters approve the *Lac Seul First Nation Land Code* and the Individual Agreement. The *Land Code* and Individual Agreement shall be approved if a majority of the participating Eligible Voters vote to approve them.

The following question will be asked of the Eligible Voters of Lac Seul First Nation by ballot:

Do you approve:

- The *Lac Seul Land Code*, dated for reference April 27, 2021; and
- The Individual Agreement with His Majesty the King in right of Canada, dated for reference July 11, 2023?

AND FURTHER TAKE NOTICE that all members of Lac Seul First Nation who are 18 years of age or older as of the date of the Ratification Vote are eligible to vote. In order to cast a vote, Eligible Voters **must** EITHER complete a Voter Declaration form when casting their vote in person, OR complete the Voter Registration Envelope when casting their vote by mail, OR complete the Electronic Voting process. **ELIGIBLE VOTERS CAN COMPLETE A DECLARATION AT THE POLLS UP TO THE CLOSE OF THE POLLS ON THE OFFICIAL VOTING DAY.**
